DEPARTMENT OF HEALTH IN BAY COUNTY PROVIDES COVID-19 UPDATE, ANNOUNCES TEN CONFIRMED CASES OF COVID-19

Panama City, Fla.— Bay County received confirmation of ten additional cases of COVID-19. Bay County residents include a 76-year-old male, an 80-year-old female, a 47-year-old female, an 18-year-old male, a 48-year-old male, a 25-year-old male, a 22-year-old male, and a 42-year-old female. Non-Florida residents include a 47-year-old female and a 21-year-old female. Four of the new cases had prior contact with a confirmed case. Two cases are travel related. Bay County's total diagnosed COVID-19 cases now stands at 123, including five non-resident cases.

DOH is conducting contact investigations and working to identify and notify individuals who need to self-monitor for symptoms for 14 days. Contact investigations are a critical way for staff epidemiologists to track and prevent the spread of disease.

Bay County's overall COVID-19 positive testing rate is 3 percent. Of the 4,383 tests processed, 4,258 tests are negative. Four Bay County residents, or 3 percent of all positive Bay County cases, have died from COVID-19. A total of 13 Bay County residents, or 11 percent of all cases, have been hospitalized with COVID-19.

Data is preliminary and subject to change based on public health investigations. Two cases from totals included in the June 5 release are now reassigned.

DOH-Bay is now testing anyone with symptoms of COVID-19, including children, at the 597 W. 11th St. location. For screening, please call DOH-Bay at (850) 872-4455 from 8 a.m. to 5 p.m. Monday through Friday and follow the prompts. Testing is by appointment only.

Symptoms of COVID-19 include:

- Fever
- Cough
- Shortness of breath
- Chills
- Muscle pain

- New loss of taste or smell
- Vomiting or diarrhea
- Sore throat
